2. What Type of Information Do We Collect?

We may collect and process the following types of personal information:

Information You Provide Directly:

When you use our website, including when you:

- Complete contact forms
- Register for events, courses or classes
- Subscribe to updates or newsletters

This may include:

- Full name
- Email address
- Telephone number
- Postal address (if required for events or administration)
- Emergency contact details (where relevant for activities)
- Information you include in messages or form submissions
- Any accessibility or support requirements you choose to share

We do not collect payment card details, billing information, or government identification numbers such as National Insurance numbers via our website.

Information Collected Automatically:

When you visit our website, we may automatically collect:

- IP address
- Browser type and version
- Device type and operating system
- Pages visited and time spent on the site
- Referring website links
- Cookie and tracking data (see Cookies section below)

This information is collected using cookies and similar technologies.

3. Why Do We Collect Personal Information?

We collect personal information for the following purposes:

- To respond to enquiries and messages
- To manage registrations for events, courses and classes
- To communicate important administrative or logistical information
- To improve our website, services and user experience
- To monitor website performance and usage
- To comply with legal and regulatory obligations
- To protect the security and integrity of our website

Where required by law, we rely on your consent. Otherwise, we process data based on:

- Legitimate interests (e.g. managing registrations)
- Legal obligations
- Performance of a task carried out in the public interest

3.1 Our Lawful Basis for Processing Personal Data

Under the UK General Data Protection Regulation (UK GDPR), we must have a valid lawful basis for processing personal data. The table below explains the types of personal data we process, why we process it, and the lawful basis we rely on.

Essential event communications	Name, email address	To send important updates relating to an event, course or class	Legitimate interests
Optional newsletters or updates	Name, email address	To share news and updates about our work (only where opted in)	Consent
Website analytics	IP address (anonymised), device and usage data	To monitor and improve website performance	Consent (via cookies)

Storage and Security

We store your personal information securely using:

- Encrypted systems where appropriate
- Secure servers and reputable third-party service providers
- Access controls to limit who can see your data

We retain personal data only for as long as necessary for the purposes outlined in this policy or to meet legal requirements.

Sharing Your Information

We do not sell your personal data.

We may share your information with:

- Trusted service providers who help us operate our website (e.g. form hosting, email services, analytics providers)
- Event partners or facilitators, only where necessary
- Legal or regulatory authorities where required by law

All third parties are required to protect your data and use it only for specified purposes.

- Help measure the effectiveness of campaigns (if applicable)

- Improve content and navigation
- Support communications and outreach activities
